

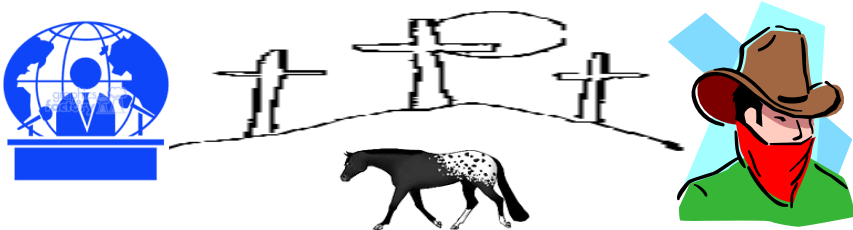

Prior riding experience will be taken into consideration. There will be no exceptions as this is for safety and insurance purposes. You may still register for the evening Bible School at any time and are encouraged to tell your friends and bring them with you.

If your child is going to ride, please commit to being there each day to keep up with the daily learning schedule. If your child is not able to come each day, please refrain from registering to ride so that the slot may be given to other children who can be here every day. Of course we certainly understand that illness or other unexpected issues may arise. The riding lesson schedule will be prepared, and a time for your child to ride will be assigned, after the registration deadline. You will then be contacted with a time slot assigned to your child. We will try our best to accommodate your requests. However, please be flexible as we will try to group the kids by age, experience, more than 1 child in the family, transportation needs, or other special needs.

We will still have an open riding session each day so we can work with those that are not attending the structured lessons. Children under the age of 6 will be lead by one of our horse volunteers, with another volunteer or a parent walking beside the child on the horse. Those attending this session can come as many days as they choose.

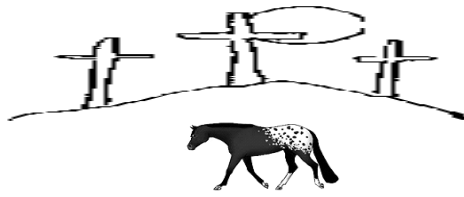
